## INSTRUCTION TO TENDERERS

### 1. SCOPE OF WORK

- 1.1 Electrical Cable Routing and Wiring for office and Machine shop equipment – CDIIC Office of CODISSIA Defence Innovation and Atal Incubation Centre (CDIIC), at Codissia Trade Fair Complex (Hall C), G.V. Fair Grounds, Avinashi Rd, Coimbatore, Tamil Nadu 641014
- 1.2 The Electrical components should preferably be made of Branded company – as per **Annexure IV**
- 1.3 The Purchase materials should be carried out by the bidders only.
- 1.4 The vendor must ensure to take precise measurement and adhere to requirement of the CDIIC
- 1.5 The vendor must ensure proper installation of Electrical works at the designated place as per CDIIC's direction.

### 2. QUALIFYING REQUIREMENT

- 2.1 Bidder shall be a registered company under the Indian Companies Act, 2256/ proprietary / partnership / Joint Venture firm. Documentary evidence regarding status of the firm shall be submitted.
- 2.2 The bidder shall be a Company / Firm / Individual specialized in making of high quality fabrication work.
- 2.3 Company / Firm / Individual should hold the valid 'A' Grade contract valid license issued by Electrical licensing board, Tamil Nadu and valid for a minimum period of 6 months from the date of bid submission
- 2.4 The bidder should have executed at least 3 similar works of the value equivalent to the quoted and the proof of the completion of the works to be attached along with the Techno-commercial bid.
- 2.5 Bidder should have valid PAN and GST Number. The bidders shall submit the copies of the same in the Bid. (**Annexure I**)
- 2.6 Duly filled and signed copy of Bidder Information and Tender Acceptance Letter as per **Annexure I** and **Annexure III** respectively.
- 2.7 The Bidder has not been blacklisted by any of the Government Organization(s) / Public Sector Undertaking(s) (PSUs). Undertaking to this effect shall be submitted along with the bid as per **Annexure II**.
- 2.8 The Tender document shall be submitted in single cover as per **Clause 3**.
- 2.9 Bidder must comply with all the criteria as mentioned at clause 2.1 to 2.6.
- 2.10 Non - compliance of any of the criteria shall result in rejection of the bid. Any hiding/misrepresentation of facts may result in rejection of the bid.

## **5 AWARD OF CONTRACT**

### **5.1 LOWEST SUCESSFUL BIDDER**

On completion of evaluation process of Bid, the Bidder whose Evaluated Amount is found to be the lowest would be declared as the Lowest (L-1) bidder.

### **5.2 LETTER OF INTENT (LOI)**

The L-1 bidder will be considered for issuing of Letter of Intent (LOI).

The acceptance of the LOI shall be submitted within 5(five) working days from issue of LOI, failing which the Department reserves the right to cancel the LOI.

## **6 GENERAL TERMS CONDITIONS**

The bidders have been permitted to tender on the explicit understanding that they shall not be entitled to resettle unilaterally from their offer or modify the terms and conditions once the same have been received in this office.

The bidder shall ensure that no damage is caused to the office documents/equipments and other items during the performance of his services/any loss suffered therein will be made good from the vendor. The Director - CDIIC, reserves the right to reject lowest, any or all the bids without assigning any reasons.

If the bidder fails to render any or all the services as per tender, the Director CDIIC reserves the right to get the services executed at the risk and cost of the firm.

The bidder will be responsible for any loss, damage or liability due to lapse on the part of its employees.

The CDIIC Team will have the right to inspect the quality of work and material to be used for rendering the service.

In case, the bidder fails to render satisfactory services, the CDIIC reserves the right to take necessary action including termination of the allotted work.

In case of the dispute relating to this tender which may arise during or after the award of the LOI, the decision of Director, CODISSIA Defence Innovation and Atal Incubation Centre (CDIIC), CODISSIA G.D.Naidu Towers, Huzur Road, Coimbatore- 641 018 will be final and binding.

## **7 EVALUATION OF PRICE BID**

- 1 Detailed contents of each Price Bid shall be reviewed during the examination of Price / Financial Proposals, to ensure that the figures provided therein are consistent with the details as per the Annexure V.
- 2 Price Bid will be checked for computational errors or material/component/accessories omissions, and prices will be corrected and adjusted as necessary. In the case of material/component/accessories omissions, the cost of the relevant Price/Financial Proposal will be decreased by application of the highest unit cost and quantity of the omitted item as provided in the other submitted price bid.
- 3 CDIIC reserves the right to use the same awarded vendor at specified approved costing in the tender for any extension works if needed.
- 4 CDIIC reserves the right to reject, at its sole discretion, any or all evaluated price bid and if necessary call for submission of new price bid. In order to allow comparison on a common basis, each price bid will be carefully scrutinized and Evaluated Tender Price for each price bid will be determined.
- 5 In case of any deficiency, CDIIC reserves its rights to reject any bid.

## **8 EVALUATION OF PRICE BID**

Pre-dispatch inspection should be arranged before clearing dispatch. However, final acceptance of the works would be done only after successful installation and commissioning at the location of Purchase.

## **9 ARBITRATION / JURISDICTION**

Any Dispute which is not resolved amicably shall be subject to the provisions of the Arbitration and Conciliation Act, 2296. The place of such arbitration shall be Coimbatore, Tamil Nadu where the Authority has its headquarters and the language of arbitration proceedings shall be English.

## **10 FORCE MAJEURE**

In the event of any unforeseen circumstances directly interfering with the supply of goods/work/service arising during the execution of order such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, earthquakes, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Bidder shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Either party shall have the option to terminate the contract on expiry of 45 days of commencement of such force majeure by giving 14 days "notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other.

## **11 ADVANCE PAYMENT**

Advance Payment at the time of placing order to the vendor will be up to a maximum of 30% of Basic price (Excluding Taxes).

\* Payment as per mutual agreed terms and the details of payments as per the LOI (Letter of Intent) or Work Order\*

## **12 Warranty**

- (i) The bidder shall offer on-site comprehensive warranty of material and workmanship for one year after the guarantee period of 1 year from the date of successful completion and certification by the CDIIC. The purchaser is not liable to pay any extra charges on any account for the replacements and the work carried out during warranty.
- (ii) The bidder must declare exclusion of warranty components (if any) along with the tender document.
- (iii) The bidder shall pay to the purchaser such compensations that may arise by reasons of the warranty therein contained but not attended by the bidder.
- (iv) If any part or parts fail or prove to be defective within the on-site warranty period specified above, owing to defect in design, material or workmanship, the bidder shall have to replace them at the place of installation without asking for any charges.
- (v) During the warranty period, technicians shall be deputed at site by the bidder within three working days from the date of request from purchaser, to rectify and fix the defects at the location. The cost of deputation of technicians and any other associated expenditure shall be borne by the bidder.
